

HOBBYCRUISES.COM TERMS AND CONDITIONS AGREEMENT

SERVICE FEE AND PAYMENT TERMS

1. SERVICE FEE STRUCTURE

By signing this agreement, Client agrees to pay a non-refundable professional service fee of \$500.00 USD per person for comprehensive premium hobby cruise planning and coordination services as detailed in the Service Planning Statement.

2. PAYMENT TERMS

- Service fee is due in full upon signing this agreement
- Payment must be received before any services commence
- Accepted payment methods: Credit card, bank transfer, or certified check
- All fees are quoted in USD and are non-refundable once services begin

3. SERVICES INCLUDED

The service fee covers:

- Professional inland transportation coordination to designated venues
- Seminar entry fees and expert access arrangements
- Pre-trip consultation and cultural briefing materials
- Real-time support during shore excursions
- Emergency contact services during planned activities

TERMS OF SERVICE

4. BOOKING AND CANCELLATION POLICY

- Service bookings are confirmed upon receipt of signed agreement and full payment
- Client cancellations made 60+ days prior to departure: Service fee retained, other costs refunded where possible
- Client cancellations made 30-59 days prior: 75% of additional costs non-refundable
- Client cancellations made less than 30 days prior: All costs non-refundable
- HobbyCruises.com reserves the right to cancel services due to circumstances beyond our control

5. FORCE MAJEURE AND SERVICE MODIFICATIONS

HobbyCruises.com is not liable for service disruptions due to:

- Weather conditions or natural disasters
- Transportation strikes or mechanical failures
- Venue closures or expert unavailability
- Government restrictions or safety concerns
- Other circumstances beyond reasonable control

Alternative arrangements will be provided when possible, but no refunds will be issued for force majeure events.

6. CLIENT RESPONSIBILITIES

Client agrees to:

- Provide accurate contact information and travel details
- Arrive at designated meeting points on time
- Follow all local laws and venue regulations
- Maintain appropriate travel insurance
- Notify HobbyCruises.com of any special requirements or limitations

7. LIABILITY LIMITATIONS

- HobbyCruises.com's total liability is limited to the service fee paid
- Client participates in all activities at their own risk
- HobbyCruises.com is not responsible for personal injury, property damage, or theft
